Review, discussion, and possible action on UCFD and Water Company Resolution 2023-06 which authorizes the execution of Addendum No. 4 to the Advance in Aid of Construction Water Facilities Agreement dated June 7, 2006, modifying the UCFD/Water Company repayment schedule.

Greg Crossman provided a presentation on agenda items #3 and #4 as they are interrelated. He went over the background of the Advance in Aid of Construction and repayment schedule and terms He explained the need for Addendum #4 modifying the UCFD/Carefree Water Company repayment schedule. It was further explained that the Carefree Water Company projected future rate increases were anticipated to be the same as they would if there was no modification to the repayment schedule and that the projected rate increases were below average for the nation. Review, discussion, and possible action on Resolution 2023-08 which, 1) authorizes the transfer of Advance in Aid of Construction funds to the Carefree UCFD/Water Company, and 2) authorizes the execution of Addendum No. 4 to the Advance in Aid of Construction Water Facilities Agreement dated June 7, 2006, modifying the UCFD/Water Company repayment schedule.
