### SUMMARY:

#### BACKGROUND

During the Fiscal Year 2023-2024 (FY23-24) Town Budget Hearings, the Carefree UCFD/Carefree Water Company requested \$2M in funding as an Advance in Aid of Construction for two infrastructure improvement projects as follows:

- Peaceful Place Booster Pump Station (BPS) Improvements
- Silver Saddle Gravity Zone Improvement Project

The approved Town Budget included a line item for this \$2M funding request.

Concurrently with this Agenda item, the Carefree Town Council will consider authorizing Town staff to transfer the requested \$2M to the UCFD/Water Company. In addition, the Town Council will consider the same revisions to the Advance in Aid of Construction repayment schedule as shown in the attached to Resolution 2023-06 which is being considered under this Agenda Item. The new repayment schedule includes repayment of the current outstanding balance, adding to it the \$2M advance, and the cost for the Town to acquire the Tom Darlington Water Storage Reservoir property.

#### **REPAYMENT SCHEDULE REVISIONS**

The revisions to the Aid in Advance of Construction (Capital Advance) repayment schedule have been developed based on discussions between the Town and UCFD/Water Company staff with the following goals in mind:

- 1. Repaying the total advance received from the Town in a reasonable time frame;
- 2. "Smoothing" the UCFD/Water Company's total debt obligation in order to minimize the impacts on our water rate payers. Other debt obligation considered in these discussions are as follows:
  - a. WIFA Loan (1MG Reservoir), \$245,000 Annually thru FY26-27
  - b. Series 2021 Water Revenue Bonds (Carefree Water Consolidation Project), \$1.1M Annually thru FY50-51

**WHEREAS**, the revised repayment schedule detailed in Exhibit "B" will fully repay the Town for the currently outstanding balance and the \$2,000,000.00 advance in a manner which moderates the annual debt obligation of the District and the Company.

WHEREAS, on June 7, 2006, the Town of Carefree ("Town") and the District entered into an Advance In Aid of Construction Water Facilities Agreement ("Agreement") which was accepted and approved by the Company; and

**WHEREAS**, Exhibit "B" of the Agreement establishes a schedule of repayment by the District and Company for certain public infrastructure improvements provided by the Town; and

**WHEREAS**, Exhibit "B" was subsequently modified three times by agreement among the Town, District, and Company; and

WHEREAS, the District and Company in good faith began making payments in FY 18-19 in accordance with latest version of Exhibit "B" and are current with payments through the end of FY 22-23; and

WHEREAS, the District and Company have incurred significant additional bonding debt for the Carefree Water Consolidation Project which entered into repayment status in calendar year 2023; and

**WHEREAS**, the District and Company have requested an additional \$2,000,000.00 Advance in Aid of Construction in order to assist with the funding of public infrastructure improvements; and

**WHEREAS**, the Town included this \$2,000,000.00 Advance in Aid of Construction in its budget authorization for Fiscal Year 2023-2024 (FY 23-24); and

**WHEREAS**, the revised repayment schedule detailed in Exhibit "B" will fully repay the Town for the currently outstanding balance, the \$2,000,000.00 advance, and the funds expended by the Town for the Tom Darlington Water Storage Reservoir property in a manner which moderates the annual debt obligation of the District and the Company.

## NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COMMON COUNCIL OF THE TOWN OF CAREFREE, MARICOPA COUNTY, ARIZONA AS FOLLOWS:

**Section 1**. Town staff are hereby authorized to transfer the sum of \$2,000,000.00 to the District/Company as an Advance in Aid of Construction; and

<u>Section 2</u>. The Mayor is hereby authorized to execute Addendum No. 4 to the Agreement, a copy of the Addendum being attached to this Resolution; and

<u>Section 3</u>. All resolutions and parts of resolutions in conflict with this Resolution are hereby repealed; and

**Section 4**. This Resolution is effective immediately.
